Remember, District of Columbia law requires a license for charitable gaming.

Dear Applicant:

Thank you for your recent inquiry concerning a fundraiser. We are sending you the information and forms needed to apply for the license you requested. Instructions are provided on the reverse side of the application. Please complete all forms and return them with a check for the appropriate amount made out to the DC Lottery.

Within ten business days of the receipt of your completed application you will be notified of your eligibility. **Please note: No tickets can be printed until you have been notified that your application has been approved.** To receive your license certificate, you must provide your printer's statement and a copy of the first and last tickets. **Only then may you sell tickets or conduct your event.** If you have any questions or need assistance, please contact me, or the Charitable Games Department staff on (202) 645-8071. We look forward to working with you on your charitable event.

Charitable Games and Licensing

Introduction

Charitable gaming is a fun way to raise money for what is often a challenging and time-consuming responsibility. The demand on available charitable dollars from corporations and philanthropies will intensify as more groups seek funding for worthwhile programs. Member of non-profit organizations must be creative and innovative in seeking ways to expand their fundraising capabilities.

The Office of Lottery and Gaming is the licensing agent for all Charitable Gaming in the District of Columbia. Any group conducting games of chance in the District of Columbia must have a license issued by the DC Lottery. The DC Lottery has developed rules, regulations and specific guidelines for the conduct of bingo games, raffles, and Monte Carlo night parties.

To qualify for a license, an organization must be incorporated in the District of Columbia as a not-for-profit organization. Not-for-profit organizations incorporated in Maryland and Virginia may also apply for a license to conduct RAFFLES in the District of Columbia. All organizations must purchase, rent or lease all equipment and supplies from a licensed supplier.

The Charitable Games division has a mission to assure that charitable gaming is at all times fair and honest and that proceeds and prizes are handled according to established rules. The rules, regulations and guidelines are designed to maximize benefits for the public at large.

This booklet provides the general guidelines and fees for license applications. Once a license is approved, specific rules for the conduct of bingo games, raffles and Monte Carlo night parties will be provided.

Charitable gaming can provide an exciting touch to your fundraising efforts. Our staff is ready to assist you with any technical information or training your organization may need to conduct the games.

Know All Men by These Present, that we, _____

the District of Columbia as Surety, and held and firmly bound unto the Office of Lottery and
Gaming, hereinafter called Obligee, in the sum of

Whereas, the above-bounden Principal has made application to the Obligee for a

D.C. Code (1981) and is required to obtain a bond in accordance with Section 2-2525, D.C.

Now, Therefore, the condition of this obligation is such that if the Principal shall conduct
themselves and their organization in accordance with the requirements of said Code, and
more specifically, shall faithfully discharge those privileges granted by the license, accurately
account for gross receipts, pay all expenses including fees and taxes and expend the net
proceeds according to law and award all prizes, then this obligation shall be null and void,

Provided However, that the total liability of the Surety hereunder in no event is to exceed the

days written notice thereof, served either personally or by registered mail, to the Principal and


