DC LOTTERY ILOTTERY POWERBALL FIRST MILLIONAIRE OF THE YEAR 2ND CHANCE CONTEST OFFICIAL CONTEST RULES

Promotional Period: September 1, 2022, September 30, 2022

1 CONTEST RULES.

- A. These rules govern the Office of Lottery and Gaming's ("DC Lottery") iLottery Powerball First Millionaire of the Year ("Contest").
- **B.** This Contest is subject to the **Powerball First Millionaire of the Year** Terms and Conditions attached hereto as Exhibit A. Exhibit A is incorporated into and made a part of these rules for all purposes.
- C. By entering the Contest or by accepting a prize awarded through this Contest, each Contestant and Winner agrees to be bound by these rules.
- **PROMOTIONAL PERIOD.** The Contest entry dates will take place from Thursday, September 1, 2022 through Friday, September 30, 2022.
- 3 ELIGIBILE ENTRIES. Contestants must be eighteen (18) years of age or older to participate in the Contest. Officers and employees of the DC Lottery and their relatives living in the same household, DC Lottery contractors, officers and employs of DCP Rights, LLC ("Dick Clark Productions"), and other persons who are otherwise disqualified, are not eligible for entry into this Contest. Contestants must make a Qualified Purchase to enter the Contest and claim a prize. Contestant's iLottery Player Account must be Know Your Customer ("KYC") verified to be eligible. Entries must meet all eligibility requirements. Eligible Contestants may enter multiple times but may only win once.
- 4 HOW TO ENTER. Contestants must make a minimum purchase of a DC iLottery Powerball ticket of \$2 dollars ("Qualified Purchase") or more during the Promotional Period. Contestants will receive one (1) draw entry per DC iLottery transaction that includes a Qualified Purchase. Contestants entries will be automatically entered into the Contest Drawing.
- 5 **DRAWINGS AND PRIZES.** There will be two (2) drawings for this Contest.
 - **A. Drawing 1.** The DC Lottery will conduct one (1) Drawing on October 4, 2022 to determine the two (2) Contestants in the DC iLottery Powerball First Millionaire of the Year Contest. The Entry Submission Start Date for Drawing 1 is September 1, 2022, beginning at 12:01 a.m., EDT. The Entry Submission Deadline for

Drawing 1 is September 30, 2022 at 11:59 p.m., EDT. Each winner of Drawing 1 will be a DC Lottery semifinalist to be entered into Multi-State Lottery Association ("MUSL") drawing among all MUSL semifinalist winners to select five (5) nationwide finalists for a chance to win the one million dollar (\$1,000,000) Grand Prize that will be awarded during *Dick Clark's New Year's Rockin' Eve* program ("Program") to be televised on ABC. Additionally, each semifinalist winner in Drawing 1 will receive A New Year's Rockin' Eve VIP Experience ("Trip Prize") Fair Market Value (FMV) of \$20,000 and the DC Lottery shall pay the taxes for the Trip Prize. One (1) prize package per winner. Each Trip Prize features A fourday, three-night trip for two (2) people to New York City, NY ("NYC") from December 29, 2022, to January 1, 2023, and shall include the following prizes:

- Round-trip, coach-class airline transportation for two (2) people from major airport nearest winner's city to New York, NY (if within 250 miles of NYC, ground transportation to be substituted) (\$2,400 FMV);
- Three (3) nights' hotel accommodations at a first-class Times Square hotel selected by Producer or such other similar comparable hotel as Producer may determine in its sole discretion in NYC (double occupancy, room and tax only) (\$7,500 FMV);
- Two (2) tickets to a welcome dinner at a venue to be selected by Producer on December 29, 2022 (\$1,000 FMV);
- Two (2) tickets for an exclusive entertainment experience to be determined by Producer (e.g., Broadway show, holiday dinner cruise on the Hudson River, etc.) on December 30, 2022 (\$1,700 FMV);
- Two (2) tickets for an exclusive New Year's Eve dinner and party with other winners of Second Chance Prizes on the Program Date (\$3,000 FMV);
- Two (2) gift bags, each with a retail value of at least Three Hundred Fifty Dollars each (\$350) (\$700 FMV);
- Meals (breakfast, lunch and dinner) while in NYC (\$600 FMV);
- Spending money in the amount of One Thousand Dollars (\$1,000) in the form of a pre-loaded gift card (\$1,000 FMV);
- Ground transportation to and from airports, hotel, and activities in NYC (\$800 FMV).

Prize Trip Winners will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize. See Section 11D for more details.

Trip prize will be subject to Producer's Trip Prize Terms and Conditions which are attached hereto as Exhibit A and incorporated herein by this reference.

- **B. Drawing 2.** The Grand Prize Drawing will occur on January 1, 2023 and be conducted by MUSL after midnight during the live broadcast of the *Dick Clark's New Year's Rockin' Eve* program. One (1) grand prize winner of one million dollars (\$1,000,000) will be selected from the pool of five (5) nationwide MUSL finalists selected in Drawing 2. The winner of the one million dollars (\$1,000,000) prize is responsible for the payment of all taxes and withholding associated with the prize.

- **C. Drawing Results.** Drawing results will be posted on www.dclottery.com within five (5) business days from the date of the Drawing.
- **D. Proxy.** If a Party Winner appoints a proxy, the proxy must sign an appearance release and clear the background check in order to participate in the broadcast of the Program. In the event that a Party Winner's designated proxy does not clear the background check, Prize Provider reserves the right, in its sole discretion, either to (i) allow the Party Winner to appoint another proxy to appear in the Program in Party Winner's place (subject to background clearance and Prize Provider deadlines); or (ii) to appoint another proxy (selected by Prize Provider) to appear in the Program in Party Winner's place.

- A proxy may be appointed to accept the one million dollar (\$1,000,000) Grand Prize on the Winner's behalf at the time of the Drawing; however, the Winner will still receive the one million dollar (\$1,000,000) Grand Prize (less any tax withholdings and any other setoff, if applicable) if proxy is used.
- E. Avoidance of Doubt. The appointment of any proxy shall not affect Winners' eligibility for the one million dollar (\$1,000,000) Grand Prize.
- **8. INDEMNITY AND RELEASE.** By entering the Contest or by accepting a prize awarded through this Contest, each entrant and winner agrees to release, indemnify and hold harmless the District, the DC Lottery and their officers, employees, agents, representatives, co-promoters, advertising agencies and contractors, and Dick Clark Productions ("Contest Entities") from liability for any claims arising out of, or related to this Contest.
- Winners must sign the DC Lottery's Acceptance and Release Form. The Acceptance and Release Form confirms the Potential Winner's and Alternate Potential Winner's compliance with these Official Contest Rules and other requirements. In addition, by signing the Acceptance and Release form, Potential Winners and Alternate Potential Winners authorize the DC Lottery and its representatives, Dick Clark Productions, American Broadcasting Companies, Inc. (ABC) and their respective parent, subsidiary, and/or affiliate entities without any further consideration, to use the Potential Winner's or Alternate Potential Winner's likeness and name, along with the city, county, state of residence of the Potential Winner or Alternate Potential Winner for advertising, reporting and promotion in any print, broadcast, electronic, internet, or other form or media whatsoever. Potential Winners and Alternate Potential Winners also release the Contest Entities and their representatives from liability of any kind and from claims arising out of this Contest or prizes awarded.
- 10. PRIZES AND OTHER RESTRICTIONS. Odds of winning any prize depend on the number of entries received. The DC Lottery and its representatives, Dick Clark Productions reserves the right to substitute prizes. A prize is not transferable once the winner has claimed. Winnings valued at more than \$600 will be reported to federal, state and District tax agencies.

11. MISCELLANEOUS.

- **A.** Only the Finalists winners are eligible to win the one million dollar (\$1,000,000) Grand Prize. The Winners' guests or proxies are not eligible to win the one million dollar (\$1,000,000) Grand Prize.
- B. The Winner and Winner's guest must travel on same itinerary. If the Winner is under the age of twenty-one (21), the Winner's guest must be at least eighteen (18) or the age of majority in the Winner guest's state of residence. If the Winner is twenty-one (21) or older, the Winner's guest may be under the age of eighteen (18) but must be at least thirteen (13) years old (as of the first date of travel), and if the Winner's guest is a minor, then the Winner must be the parent or legal guardian of the Winner's guest.
- C. Upon submitting an entry, the Contestant(s) agree that they are subject to certain restrictions required by DCP Rights, LLC and/or Network, including, without limitation, Winner and Winner's guest signing an appearance release and clearing a background check to establish their eligibility which will be determined and managed by the Producer and/or Network at their sole discretion.
- **D.** All expenses involved with or related to the Trip Prize not specifically included in the description of the Trip Prize, including, without limitation, ground transportation, transfers, additional hotel amenities (i.e., spa services, internet access, phone calls, laundry services), fees and gratuities, airline change fees, airline premium seat fees, airline baggage fees (both checked and carry on), and personal expenses such as laundry, valet service, photos, souvenirs, and other incidentals, are the responsibility of the Winner and Winner's guest.
- E. As is standard in most U.S. hotels, the hotel requires a deposit at the time of check in to cover all expenses not specifically awarded as part of the Trip Prize. - **H.** No prize element substitution, cash substitution, assignment, or transfer of the Trip Prize or any elements thereof is permitted. Any unused elements of the Trip Prize

will be forfeited, will not be redeemable for cash, and may not reduce the prize value awarded for tax purposes. Notwithstanding the foregoing:

- If a Winner misses their flight, reasonable efforts will be made to reschedule the flight at the Winner's expense.
- If the flight is not able to be rescheduled in a reasonable time for the Winner's participation in the events, the Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the events.
- Winner will still receive the gift card and spending money portion of the Trip Prize (less any tax withholdings and any other setoff, if applicable); and
- Winner will remain eligible for the one million dollar (\$1,000,000.00) Grand Prize drawing, with proxy assigned.
- I. If a Winner is unable to travel in connection with the Trip Prize for any reason after tickets have been booked, Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the events. The Winner will still receive the gift card and spending money portion of the Trip Prize (less any tax withholdings and any other setoff, if applicable); and the Winner will remain eligible for the one million dollar (\$1,000,000.00) Grand Prize drawing, with proxy assigned.
- J. A proxy may be appointed to accept the one million dollar (\$1,000,000.00) Grand Prize on the Winner's behalf at the time of the drawing; however, the Winner will still receive the one million dollar (\$1,000,000.00) Grand Prize (less any tax withholdings and any other setoff, if applicable).
- 12. LIMITATION OF LIABILITY. All decisions regarding the Contest including, without limitation, winner selection, disposition of a prize, payment of taxes, selection of alternates, photograph suitability for public display, application and interpretation of the Official Contest Rules, resolution of any dispute or Contest eligibility shall rest solely with the Executive Director of the DC Lottery ("Executive Director") or the Executive Director's designee and shall not be subject to appeal. The Executive Director may change the date, time and location of the Drawings. This Contest is subject to cancellation at any time. The Executive Director reserves the right to change and supersede any outlined procedures or rules to handle unforeseen circumstances. The Contest Entities are not responsible or liable for entries or notifications and required documents that are not otherwise in compliance with these Official Contest Rules, whether caused by any of the equipment or programming associated with or utilized in the Contest, or by any technical or human error which may occur in the processing of Eligible Entries into the Contest, or for failure to receive Eligible Entries due to transmission failures or technical failures of any kind and such noncompliant entries will be disqualified. By entering the Contest, each Contestant irrevocably agrees

- Ground transportation to and from airports, hotel, and activities in NYC (\$800 FMV).

Prize Trip Winners will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize. See Section 11D for more details.

- **D. Proxy.** If a Party Winner appoints a proxy, the proxy must sign an appearance release and clear the background check in order to participate in the broadcast of the Program. will be forfeited, will not be redeemable for cash, and may not reduce the prize value awarded for tax purposes. Notwithstanding the foregoing:

- If a Winner misses their flight, reasonable efforts will be made to reschedule the flight at the Winner's expense.
- If the flight is not able to be rescheduled in a reasonable time for the Winner's participation in the events, the Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the events.
- Winner will still receive the gift card and spending money portion of the Trip Prize (less any tax withholdings and any other setoff, if applicable); and
- Winner will remain eligible for the one million dollar (\$1,000,000.00) Grand Prize drawing, with proxy assigned.
- I. If a Winner is unable to travel in connection with the Trip Prize for any reason after tickets have been booked, Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the events. The Winner will still receive the gift card and spending money portion of the Trip Prize (less any tax withholdings and any other setoff, if applicable); and the Winner will remain eligible for the one million dollar (\$1,000,000.00) Grand Prize drawing, with proxy assigned.
- J. A proxy may be appointed to accept the one million dollar (\$1,000,000.00) Grand Prize on the Winner's behalf at the time of the drawing; however, the Winner will still receive the one million dollar (\$1,000,000.00) Grand Prize (less any tax withholdings and any other setoff, if applicable).
- 12. LIMITATION OF LIABILITY. All decisions regarding the Contest including, without limitation, winner selection, disposition of a prize, payment of taxes, selection of alternates, photograph suitability for public display, application and interpretation of the Official Contest Rules, resolution of any dispute or Contest eligibility shall rest solely with the Executive Director of the DC Lottery ("Executive Director") or the Executive Director's designee and shall not be subject to appeal. The Executive Director may change the date, time and location of the Drawings. This Contest is subject to cancellation at any time. The Executive Director reserves the right to change and supersede any outlined procedures or rules to handle unforeseen circumstances. The Contest Entities are not responsible or liable for entries or notifications and required documents that are not otherwise in compliance with these Official Contest Rules, whether caused by any of the equipment or programming associated with or utilized in the Contest, or by any technical or human error which may occur in the processing of Eligible Entries into the Contest, or for failure to receive Eligible Entries due to transmission failures or technical failures of any kind and such noncompliant entries will be disqualified. By entering the Contest, each Contestant irrevocably agrees
